Maximum concentration: 3%	Rate	Application Timing
Fruit & Nut Trees	2-3 pts/acre	2-3 applications after fruit setting and then every 14 days
Grapes	2-3 pts/acre	2-3 applications every 14 days after flowering
Citrus	2-3 pts/acre	2-3 applications every 14 days after flowering
Red Berries	2 pts/acre	2-3 applications from the start of flowering and then every 15 days
Potatoes	2-3 pts/acre	2-3 applications every 15 days starting at 20-30% of final tuber mass reached
Tomatoes	2-3 pts/acre	After fruit setting
Melons	2-3 pts/acre	After fruit setting
Field Crops (Corn, Cotton, Soybean, Sunflower, Peas...)	2 pts/acre	1 application from 10 leaf stage through flowering
Cereals & Forage Crops	2-3 pts/acre	1 application as soon as the foliage is sufficiently developed for good coverage
