## RECOMMENDED USES FOR FOLIBAC ULTRA

Uniformly apply the suggested rates in the following amounts of water per acre. Do not spray to run off from plants

## DIRECTIONS FOR USE

**SHAKE BEFORE USE:** For better efficacy use the product alone in a spray. Clean sprayer before use and avoid any delays between mixing active ingredient and use. Do not use in chlorinated water. Do not apply the product within 4 days before or 7 days after herbicide spraying. Can be mixed with most fertilizers and fungicide solutions, only after dilution in the final mixture. When mixed with other products, always perform a compatibility test first. Add the product in last.

FOR FOLIAR APPLICATION on sufficiently developed foliage during rapid growth phase:			
	Dilution	Rate	Application Timing
Cereals	10-25 g/acre	7-8 fl oz/acre	At stem elongation (1-2 nodes above tiller node)
Canola	10-25 g/acre	7-8 fl oz/acre	Beginning of stem elongation, rosette, no internodes,
Corn, Potatoes & Sunflower	10-25 g/acre	7-8 fl oz/acre	At 4-5 leaves unfolded
Soybean	10-25 g/acre	7-8 fl oz/acre	At V2 stage, 2nd trifoliate leaf unfolded
Cotton	10-25 g/acre	7-8 fl oz/acre	2-3 true leaves unfolded
Vegetables	10-25 g/acre	7-8 fl oz/acre	2-3 true leaves unfolded
Grapes & Hops	50-100 g/acre	7-8 fl oz/acre	6th leaf unfolded until flowering
Fruit & Nut Trees	50-100 g/acre	7-8 fl oz/acre	Beginning of shoot elongation to 50% complete
Berries & Small Fruit	30-100 g/acre	7-8 fl oz/acre	3-4 leaves unfolded to fruit set (strawberries) or shoot elongation 50% complete

**STORAGE CONDITIONS:** Keep in original container out of direct sunlight, tightly closed, in a safe place AWAY FROM CHILDREN and ANIMALS AND AT A TEMPERATURE OF BETWEEN AND including 39° F and 77° F. Store away from frost. Do not expose to frost and temperatures > 95° F.
